Cooperative Societies in Madhya Pradesh

2278. SHRI GAJENDRA SINGH PATEL: SHRI DURGA DAS (D.D.) UIKEY:

Will the Minister of COOPERATION (सहकारिता मंत्री) be pleased to state:

- (a) the number of registered cooperative societies in Madhya Pradesh, district-wise;
- (b) the name of schemes of the cooperative societies which are directly benefitting farmers and the number of farmers benefitted from those schemes in Madhya Pradesh till now, district-wise;
- (c) the name of areas where the Government is working to promote cooperatives in future;
- (d) the name of cooperative societies in the State of Madhya Pradesh which are being provided grants for their development during the last three years and the quantum of funds provided to them; and
- (e) the details of work being done by the cooperative societies in the tribal areas?

ANSWER

MINISTER OF COOPERATION सहकारिता मंत्री (SHRI AMIT SHAH)

(a) to (e): As per Statistical Profile – 2018 Published by NCUI, the total number of cooperative societies in Madhya Pradesh is 47,415. The sector wise details of cooperative societies in Madhya Pradeshare annexed at **ANNEXURE-1.**

One of the mandates of the Ministry is "Strengthening of cooperative movement in the country and deepening its reach up to the grassroots". Ministry of Cooperation has taken several initiatives for the cooperative societies which are directly benefitting farmers across the country, including the state of Madhya Pradesh, such as:

- i. On 29th June 2022, the Ministry launched a centrally sponsored project "Computerization of Primary Agriculture Credit Societies (PACS)" with a budgetary outlay of Rs 2,516 crores for digitalization of 63,000 functional PACS which are at the bottom of the three-tier rural credit structure. This project will bring transparency and efficiency in their operation. Societies similar to PACS in tribal areas such as Large Area Multipurpose Societies (LAMPS) will also be benefited from the Computerization of PACS project.
- ii. The Ministry has also prepared Model Byelaws after consultation with all the stakeholders including States/ Union territories. These Model Byelaws of PACS would enable them to undertake more than 25 business activities like dairy, fishery, setting up of godowns, procurement of foodgrains, fertilizers, seeds, etc.
- iii. National Cooperative Development Corporation (NCDC), a statutory organization under the Ministry of Cooperation, provides financial assistance to the cooperative sector and undertakes various activities such as strengthening share capital base of primary/ District cooperative marketing societies, setting up of processing centres, storage facilities, establishing and modernizing cold chain, creation of cooperative banking units, agricultural services, Integrated Cooperative Development Projects, etc.

There are other schemes of various Ministries/ Departments of Government of India for providing benefits to the cooperatives such as:

- i. Agriculture Infrastructure fund (Ministry of Agriculture and Farmers Welfare) Interest subvention of 3% and credit guarantee is provided by the Government for availing loan up to Rs. 2 crore per project for infrastructure projects at farm gate by FPO, PACS, entrepreneurs, start-ups and other beneficiaries.
- ii. Agricultural Marketing Infrastructure (Ministry of Agriculture and Farmers Welfare) –Subsidy at the rate of 25% to 33.33% is available to the eligible beneficiaries through the channelizing agencies i.e. NABARD, NCDC, DA&FW, etc. for holistic development of agricultural value chain including promotion of value addition and processing at farmers level so as to enhance their income.
- iii. Sub-Mission on Agricultural Mechanization (SMAM) (Ministry of Agriculture and Farmers Welfare) The scheme envisages setting up of custom hiring centers and hubs for hi-tech and high value farm equipment. The equipment will be available on rental basis to the farmers and subsidy at the rate of 40% is available for projects costing upto Rs. 60 lakh.
- iv. Mission for Integrated Development of Horticulture (MIDH) (Ministry of Agriculture and Farmers Welfare) This scheme covers various activities under Horticulture Sector such as setting up of new orchards for fruits, vegetables and flowers, creation of poly-houses, greenhouses, etc. These activities will get subsidy in the range of 25-55%.
- v. Pradhan Mantri Kisan Sampada Yojana (PMKSY) (Ministry of Food Processing Industries) It aims to create modern infrastructure with efficient supply chain management from farm gate to retail outlet. A subsidy of up to 35% of the project cost is provided under this scheme which can go up to 50% in difficult areas for infrastructure facilities such as cold room, cold storage, integrated pack house for primary processing etc.
- vi. PM Formalization of Micro Food Processing Enterprises Scheme (PMFME) (Ministry of Food Processing Industries) The Scheme adopts 'One District One Product' approach. Under the Group category, Cooperatives can avail 35% subsidy (up to ₹10 Lakh) for upgradation of food processing units. ₹ 3 Crore credit-linked grant is available for setting up of common infrastructure like common processing facility, premise for sorting, grading, warehouse and cold storage at farmgate, incubation centre, etc.
- vii. Tribal Co-Operative Marketing Development Federation of India Limited (TRIFED) spearheads implementation of Van Dhan programme for collection and selling on Minor Forest Produce (MFP) in Districts which have predominantly forest dwelling tribal population. The idea is to setup tribal community-owned Van Dhan Vikas Kendra Clusters (VDVKCs) in the Tribal Districts. For this purpose, 100 % assistance is provided by the Government to the collectives in the form of SHGs/ Van Dhan Kendras.

All the schemes of Government of India are oriented towards revitalizing the Cooperative sector in all States/ Uniton Territories and in all areas, including the tribal areas of the state of Madhya Pradesh. The financial assistance provided by National Cooperative Development Corporation (NCDC) to the cooperatives in Madhya Pradesh in last 3 years are annexed at **ANNEXURE – 2**.
