# RAJYA SABHA UNSTARRED QUESTION NO. 643 TO BE ANSWERED ON 08/02/2023

#### **Cooperative Sugar Mills**

#### 643 : Dr. Ashok Kumar Mittal:

Will the Minister of Cooperation be pleased to state:

- (a) how many Cooperative sugar mills are registered in the country, State-wise details thereof;
- (b) whether Government has established any policy to subsidise sugar producting cooperatives and if so, the details including the aims and objectives thereof;
- (c) whether the policy has been able to achieve the objectives, if so, the details thereof; and
- (d) the total amount released by Government for the policy during the current year and the actual amount spent thereon?

#### **ANSWER**

MINISTER OF COOPERATION सहकारिता मंत्री (SHRI AMIT SHAH)

(a) to (d): As per information provided by Department of Food and Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, there are 316 co- operative sugar mills registered across the country. State-wise distribution is at **ANNEXURE-I**.

Though there is no separate subsidy scheme for cooperative mills, all sugar mills including those of cooperative sector have been provided financial assistance under buffer stock subsidy and export subsidy schemes during 2018-21. Basic objective of these schemes was to give financial assistance to sugar mills so that cane arrears of farmers may be cleared early by these mills. Further, under these schemes a sum of ₹16,776.22 Crore was disbursed to all sugar mills including co- operative sugar mills. A statement showing scheme wise disbursement may be seen at ANNEXURE-II.

Each sugar mill opened a separate escrow account in which the subsidy amount was credited which was released to farmers to clear their dues before balance payment was given to the sugar mill. Cane arrears of farmers, which were at its peak during 2018-19 sugar season were reduced up to the extent that 99.9% of cane arrears of farmers of Sugar season 2020-21 and earlier seasons have been cleared while 99% cane arrears of sugar season 2021-22 have been cleared by sugar mills. Therefore, the schemes achieved their objectives.

About ₹40 Cr. have been allocated to Department of Food and Public Distribution during RE 2022-23 for release to sugar mills including cooperative sugar mills.
