### Implementation of CSISAC

Will the Minister of COOPERATION (सहकारिता मंत्री) be pleased to state:

- (a) whether the Government has been implementing Central Sector Integrated Scheme on Agricultural Cooperation (CSISAC) and if so, the details thereof;
- (b) the details of funds sanctioned and progress made under the scheme during the last three years, component and State-wise; and
- (c) other steps being taken by the Government for effective implementation of the scheme?

#### **ANSWER**

THE MINISTER OF COOPERATION सहकारिता मंत्री (SHRI AMIT SHAH)

(a): Yes Sir, since 12<sup>th</sup> Five Year Plan, the Central Sector Integrated Scheme on Agricultural Cooperation (CSISAC) has been implemented by the Government of India. The scheme was operational till 31<sup>st</sup> March 2023.

The CSISAC scheme had the following components:-

- (i) Assistance to National Cooperative Development Corporation (NCDC) Programmes for Development of Cooperatives under this scheme subsidy was provided to cooperative societies through NCDC.
- (ii) Assistance to Cooperative Education and Training –implemented through the National Cooperative Union of India (NCUI) and the National Council for Cooperative Training (NCCT).
- (iii) Assistance to Multi State Cooperative Societies.
- (b): CSISAC was a Central Sector Scheme, hence the amount had been disbursed to the Central Government agencies designated as Implementing Agencies under the scheme viz. National Cooperative Development Corporation (NCDC), National Council for Cooperative Training (NCCT), National Cooperative Union of India (NCUI) and to Multi State federations.

Total financial assistance under the scheme, component-wise for last 3 years (2020-21, 2021-22 and 2022-23) is mentioned as below:

Under the scheme, NCDC provided financial assistance in the form of subsidy/grant to the Cooperative societies across the country, while NCCT and NCUI utilized the grant for cooperative training and capacity building.

Further, the State-wise details of financial assistance sanctioned and disbursed by NCDC during last three years (2020-21, 2021-22 and 2022-23) is attached at Annexure -1.

(c): For the effective implementation of the scheme, the financial assistance is disbursed to the Implementing Agency through the Treasury Single Account (TSA) / Central Nodal Agency (CNA) model under the Public Financial Management System (PFMS). The Implementing Agency viz. NCDC also disburses grant/subsidy under the scheme to beneficiary cooperative societies through PFMS model only.
