## LOK SABHA UNSTARRED QUESTION No. 4967 TO BE ANSWERED ON 1st APRIL, 2025

#### **Shut down of Cooperative Societies**

### 4967: Shri Charanjit Singh Channi:

Will the Minister of Cooperation (सहकारिता मंत्री) be pleased to state:

- (a) the number of cooperative societies that have shut down in Punjab and across the country in the past three years, along with the r easons for their closure;
- (b) whether the Government has conducted any review or assessment of the financial and operational challenges faced by these cooperative societies;
- (c) the steps taken by the Government to revive defunct cooperative societies and prevent further closures;
- (d) whether any financial assistance, restructuring plans, or policy reforms have been introduced to strengthen cooperative societies; and
- (e) the details of any measures to ensure better governance, transparency and accountability in cooperative societies across the country?

#### **ANSWER**

## THE MINISTER OF COOPERATION सहकारिता मंत्री (SHRI AMIT SHAH)

- (a) As per National Cooperative Database (NCD), the State-wise number of non-functional cooperative societies in the country including Punjab in the past three years from 01.03.2022 to 01.03.2025, is attached as **Annexure 1.**
- (b) Yes sir. Three National Cooperative Societies, namely National Cooperative Union of India (NCUI), National Federation of State Cooperative Banks (NAFSCOB), and National Federation of Urban Cooperative Banks and Credit Societies (NAFCUB), have been assigned to conduct seven different studies as detailed in **Annexure-2**.
- (c) Ministry of Cooperation has set up Co-operative Rehabilitation, Reconstruction and Development Fund under section 63A of the Multi-State Cooperative Societies (MSCS) (Amendment) Act, 2023 for revival of sick multi-State cooperative societies and providing

assistance for meeting infrastructural requirement. Additionally, the Ministry of Cooperation has taken proactive measures to convert Primary Agricultural Credit Societies (PACS), Dairy, and Fisheries Cooperatives into multi-purpose cooperative societies. This initiative aims to enhance business diversification, strengthen financial sustainability, and prevent closures by enabling cooperatives to engage in a wider range of economic activities.

- (d) & (e) The Multi-State Cooperative Societies (MSCS) Act, 2002 was amended in 2023 to strengthen governance, enhance transparency, increase accountability and reform electoral process, etc. in the Multi State Cooperative Societies. Several other initiatives have been taken by the government in form of policy reforms to strengthen the cooperative societies and ensure better governance, transparency and accountability:
  - i) Making Primary Cooperatives economically vibrant and transparent;
  - ii) Strengthening the Urban and Rural Cooperative Banks;
  - iii) Relief to Cooperative Societies in the Income Tax Act;
  - iv) Revival of Cooperative Sugar Mills;
  - v) Three new National Level Multi-State Societies;
  - vi) Capacity Building in Cooperatives;
  - vii) Use of Information Technology for 'Ease of Doing Business' etc.;
