



Disputed tax waived for Maha's coop sugar sector, sops for agricultural credit societies

MUMBAI: The budget presented by finance minister Nirmala Sitharaman in Parliament on Wednesday had no major announcements for poll-bound Mumbai but it could benefit the rural economy in Maharashtra.

The announcement of modernisation of primary agricultural credit societies (PACS) and the respite from the disputed income tax pending with sugar factories is expected to give a boost to the agriculture and cooperation sectors in Maharashtra. More than 21,000 PACS in the state will benefit, as they will now get the status of multipurpose societies, while 72 cooperative sugar factories will get their disputed income-tax totalling Rs 10,500 crore set aside.

Though the outlay for Maharashtra will be known only after

the fine print of the budget is released, the announcements for the agriculture and cooperation sectors have been well received. PACS play a key role in boosting the rural economy in the cooperation sector, and the Centre's decision to enable them to become multipurpose societies and modernise, fund and handhold them to help them spread their wings will benefit the rural economy. Maharashtra has over 21,000 PACS, of which 12,000 are being computerised in the first phase. With the additional funding, the farmers dependent on these are expected to greatly benefit.

"The computerisation and the direct monitoring by the district central cooperative banks will help weed out the financial irregularities that are synonymous with these societies," said an official from the cooperation department. "The PACS that are in good financial health have

been active in other auxiliary sectors like processing, operation of petrol pumps and warehousing. With the central assistance announced in the budget, all PACS will now be able to resort to these activities and help in strengthening them financially. This will also help the cooperative sector to get rid of private money lenders who exploit farmers."

Deputy chief minister Devendra Fadnavis said, "The decision related to the PACS will give the cooperative movement strength at the rural level. They can now take up 20 types of schemes, including those related to cold storage and automobiles."

The central government's decision to treat the disputed profit of sugarcane factories as FRP expenditure instead of profit will give a major respite to cooperative sugar factories. The cooperative sugar sector is the backbone of the rural econ-

omy in western and some other parts of Maharashtra.

"The dues were raised by the income-tax department, treating the difference between procurement price fixed by the government and that actually paid by the sugar factories as profit," said sugar commissioner Shekhar Gaikwad.

"The disputed amount pending since 1970 from about 72 cooperative sugar factories amounts to Rs 10,500 crore, interest included. The central government decision announced in the budget will help clear the account books of the factories."

Both decisions of the centre are being seen as politically significant ahead of the local body polls expected to be conducted in the next few months. "Both will have a significant impact on the cooperative sector, which is the stronghold of the Congress and NCP." a BJP leader said.

Shah welcomes 'unprecedented' decisions for cooperative sector

FROM RAISING outlay of the Ministry of Cooperation and tax relief for cooperatives to set up "massive" decentralised storage capacity — these are among the key announcements for the cooperative sector made in the Union Budget 2023-24.

In her budget speech, Sitharaman said, "For farmers, especially small and marginal farmers, and other marginalised sections, the government is promoting cooperative-based economic development model. A new Ministry of Cooperation was formed with a mandate to realise the vision of 'Sahakar Se Samriddhi'. To realise this vision, the government has already initiated computerisation of 63,000 Primary Agricultural Credit Societies (PACS) with an investment of Rs 2,516 crore. In consultation with all stakeholders and states, model bye-laws for PACS were formulated enabling them to become multipurpose PACS. A national cooperative database is being prepared for country-wide mapping of cooperative societies."

"With this backdrop, we will implement a plan to set up massive decentralised storage capacity. It will help farmers store their produce and realise remunerative

prices through sale at appropriate times," Sitharaman said.

The Finance Minister also announced tax reliefs for the cooperative sector. An allocation of Rs 1,149.38 crore has been made for 2023-24, which is higher than the BE of Rs 900 crore in 2022-23 but lower than the current year's revised estimates of Rs 1624.74 crore.

In his remarks on Budget 2023-24, Prime Minister Narendra Modi said, "This budget will make cooperatives the pivot of development of the rural economy. The government has brought the world's largest food storage scheme in the cooperative sector-storage capacity"

Minister of Home and Cooperation Amit Shah called the decisions "unprecedented", saying, "With the plan of setting up the world's largest decentralised storage capacity, farmers associated with cooperative societies will be able to get fair prices." Shah said that in the next 5 years, the government will also establish new multipurpose cooperative societies, primary fisheries societies and dairy cooperative societies in every panchayat.

Shah also welcomed the announcement, in which sugar cooperatives have been given the facility to show the payments made to farmers before 2016-17 in their expenditure.





erming it "historic", Prime Minister Narendra Modi on Wed-nesday said the first Budget in "Amrit Kaal" had established a strong base to fulfil the resolve of a developed India and dreams of the aspirational, including the poor and the middle income-group.

In his first reaction to the Budget 2023-24, Modi said in order to empower the middle-income groups, the government had taken many significant decisions in the past years

that ensured ease of living. He underlined the potential of the middle-income gro-ups in realising the dreams of 2047, and also highlighted the reduction in tax rates as well as the simplification, transpar-ency and speeding up of pro-cesses. "Our government, which always stood with the middle class, has given huge tax relief to them." Modi said.

The prime minister congratulated Sitharaman and her team for a "historic" Budget.

Modi called the traditional artisans such as carpenters, iron smiths, goldsmiths, potters, sculptors and many others as the creators of the nation.

"For the first time, the country has come up with many schemes as a tribute to the hard work and creation of these people. Arrangements have been made for training, credit and market support to them. PM Vishwakarma Kaushal Samman, that is, PM ViK-aS, will bring a big change in the lives of crores of 'Vishwa-

karmas'," Modi said.

This Budget, the PM said, will make cooperatives a fulcrum of development of the rural economy. The govern-ment, he said, has come up with the world's largest food storage scheme in the co-operative sector, and an ambitious scheme to form new primary co-operatives had also been

announced in the Budget. Emphasising the need to replicate the success of digital payments in agriculture, Modi said this Budget came with a big plan for digital agri infrastructure. Noting that the world was celebrating the International Year of Millets,

he said there were many types of millets in India and their recognition was warranted.

"This superfood has been given a new identity of 'Shree-Anna'," Modi said, underlining that it would provide econ omic support for small farmers and tribal farmers.

This Budget, Modi said, will give an unprecedented expansion to green growth, green economy, green infrastructure, and green jobs, for a sustainable future. "In the Budget, we have laid a lot of emphasis on technology and the new economy. The aspirational India of today wants modern infrastructure in every field like road, rail, metro, port, and waterways. Compared to 2014, investment in infrastructure has increased by more than 400 per cent."

The unprecedented invest-ment of ₹10 trillion on infrastructure will give new energy and speed to India's development, the PM said.



The government proposes to spend ₹1,150.38 crore on the cooperatives sector in FY24, with ₹968 crore earmarked for computerisation of some 63,000 primary cooperative agriculture societies (PCAS).

The total cost for computerisa-tion of PCAS is estimated at ₹2,516 crore. The scheme aims to computerise PCAS, leading to an increase in its efficiency, pro-fitability, transparency and accountability.

"The budget further makes pro-vision to set up decentralised storage capacity so that farmers can store their produce and realise remunerative prices to sell at an appropriate time," read a statement issued by the cooperative ministry. "The government will facili-tate setting up of a large number of multipurpose cooperatives socie-ties, primary fishery societies, and dairy cooperative societies in uncovered panchayats and villages in the next five years."

The announcement comes close on the heels of the Cabinet decision to set up three new coopera-tive societies to boost organic farming, seeds and exports, with

the aim to push up farm income.
As per the budget announcement, new cooperatives commen-cing manufacturing by March 31, 2024 will get the benefit of a lower tax rate of 15%, while higher limit of ₹2 lakh per member has been earmarked for cash deposit and loans in cash by PACS and prima-ry cooperative agricultural and rural development banks. A hig-her limit of ₹3 crore for TDS on cash withdrawal has been provided to cooperative societies, the statement said.

Finance minister Nirmala Sitharaman said in her budget speech that a national cooperative database for countrywide map-

ping of coopera-tive societies will be created for Govt to create better a national implementation of the cooperative proposed natio-nal policy on coocountrywide peratives.
"Setting up of mapping of

there is no distress sale of farm products and farmers get better price for their produce," Jayen Mehta, incharge managing di-rector of Gujarat Cooperative Milk Marketing Federation (GCMMF).

"The government will facilitate setting up of a large number of multipurpose cooperatives socie-ties, primary fishery societies, and dairy cooperative societies in uncovered panchayats and villages in the next five years."

The announcement comes close on the heels of the Cabinet decision to set up three new cooperative societies to boost organic farming, seeds and exports, with the aim to push up farm income.

As per the budget announcement, new cooperatives commen-cing manufacturing by March 31, 2024 will get the benefit of a lower tax rate of 15%, while higher limit of ₹2 lakh per member has been earmarked for cash deposit and loans in cash by PACS and prima-ry cooperative agricultural and rural development banks. A higher limit of ₹3 crore for TDS on cash withdrawal has been provided to cooperative societies, the statement said.

Finance minister Nirmala Sitharaman said in her budget speech that a national cooperative database for countrywide map-

"Setting up of cooperatives

will ensure that there is no distress sale of farm products and farmers get better price for their produce," Jayen Mehta, incharge managing director of Gujarat Cooperative Milk Marketing Federation (GCMMF).

In a relief to sugar cooperative mills, the claims for payments ma-de to sugar farmers prior to assessment year 2016-17 will be considered as 'expenditure'. This is likely to provide a relief of about ₹10,000 crore to the sugar cooperatives, according to the ministry of cooperation. The department was taken out from the agriculture ministry and created into a separate ministry by Prime Minister Na-rendra Modi in July 2021.

Tax Incentives to Give a Leg Up to Coop Sector

To support an inclusive growth model and incentivise the bottom of the pyramid, the finance minister unveiled new tax benefits for cooperative bodies, and investments in their technology infrastructure. The budget announcement comes weeks after the Cabinet relaxed rules for cooperatives to participate in India's growth story.

Nirmala Sitharaman announced that new cooperatives that commence manufacturing activities till March 31, 2024 would be taxed at a flat 15% — the low rate available to new manufacturing companies — from the current rate of up to 30% plus surcharge. Sugar cooperatives will be able to claim as expenditure their payments to sugarcane farmers for the period prior to assessment year 2016–17. "This is expected to provide them with nearly ₹10,000 crore in reli-

ef," Sitharaman said.

The budget also proposes to cap the limit at ₹2 lakh per member for cash deposits and loans in cash by primary agricultural cooperative societies (PACS), and primary cooperative agriculture and rural development banks. Cooperative societies have been provided a higher limit of ₹3 crore for tax deducted at source on cash withdrawals, against ₹1 crore now.

The government has already initiated computerisation of 63,000 PACS with an investment of ₹2,516 crore, in addition to setting up a national cooperative database and preparing a country-wide map of cooperative societies. Also, model by-laws have been formulated for such cooperatives to become multipurpose PACS.

The finance minister's measures come three weeks after the Cabinet approved the setting up of a national-level multi-state cooperative organic society under the Multi-State Cooperative Societies Act, 2002.

'India will have world's largest decentralised farm storage capacity'

With the Budget announcement to set up decentralised storage capacity, Cooperation Minister Amit Shah has said that India will have the world's largest decentralised storage capacity in the cooperative sector which will help farmers store their produce and sell at the right time to get a fair price.

"This will play an important role in (Prime Minister Narendra) Modi's resolve to increase the income of farmers," Shah said. In the next five years, the government will facilitate the establishment of new multipurpose cooperative societies, primary fisheries societies and dairy cooperative societies in every panchayat, he added.

AMENDING ACT

In her Budget speech, Sitharaman announced a higher limit of ₹2 lakh per member for cash deposits and loans in cash by Primary Agricultural Co-operative Societies (PACS) and Primary Co-operative Agriculture and Rural Development Banks (PCARDBs).

New cooperative societies that are formed on or after April 2023 are proposed to be allowed an option to pay tax at a concessional

rate of 15 per cent similar to what is available to new manufacturing companies, she announced, as such a step will promote growth of manufacturing in cooperative sector.

She also said Sections 269SS and 269T of the Companies Act will be amended to ensure that there is no penalty for cash loan/transactions against primary co-operatives for cash less than ₹2 lakh, which was a major demand of the cooperative unions. Sitharaman also agreed to increase the threshold limit for co-operatives to withdraw cash without TDS. "It is proposed to en-

able co-operatives to withdraw cash up to ₹3 crore in a year without being subjected to TDS on such withdrawal," she said.

With an estimated relief of about ₹10,000 crore, the government has allowed sugar cooperatives to claim payments made to cane growers for the period prior to the assessment year 2016-17 as expenditure.

Shah said the cooperative movement will get new direction and momentum. "Today, the unprecedented decisions taken in the Budget to strengthen the cooperative sector are a symbol of this resolution," he said.

HIKE IN OUTLAY

Though the Cooperation Ministry has received lower allocation of ₹1,150.38 crore for 2023-24, from ₹1,624.74 crore for 2022-23 (RE) due to discontinuation of some schemes previously run by Agriculture Ministry, the outlay for computerisation of PACS has been hiked to ₹968 crore for the next fiscal from ₹350 crore this year (RE).

To realise the vision of 'Sahakar Se Samriddhi', Sitharaman said the government has already initiated computerisation of 63,000 PACS with an investment of ₹2,516 crore.

आजाद भारत के अमृत काल का पहला बजट लगभग अपेक्षा के अनुरूप ही रहा है। सबसे अपनी दोस्ती, ना काहू से बैर के भाव के साथ इस बजट में चुनावी वर्ष की छाया भी साफ तौर पर महसूस हो रही है। वैश्विक मंदी और रूस-यूक्रेन युद्ध का अपना असर है, इसके बावजूद वित्त मंत्री ने अपनी सीमाओं के अंदर एक सकारात्मक भविष्योन्मुख बजट पेश किया है। कुछ योजनाओं को पूरा करने के लिए तीन साल से पांच साल तक का समय लिया गया है, मतलब सरकार अपनी घोषणाओं में किसी भी तरह के बड़बोलेपन से बचने में कामयाब रही है। आज के समय में अर्थव्यवस्था जिस मोड़ पर है, वहां किसी भी विशेष वर्ग को निशाने पर नहीं लिया जा सकता। एक ओर, जरूरतमंदों को राहत पहुंचाने के लिए विभिन्न मदों में बजट की बढ़ोतरी हुई है, वहीं बड़ी कंपनियों और निवेशकों की चिंता भी सरकार स्पष्ट रूप से कर रही है। कंपनियों और निवेशकों की तात्कालिक खुशी को इस बात से समझा जा सकता है कि बजट आते ही शेयर बाजार में बढ़त का क्रम दिखा। हालांकि, कुछ समय बाद गिरावट हुई, पर तब भी बाजार ने समग्रता में नुकसान का संकेत नहीं दिया। यह सरकार के लिए एक राहत की बात हो सकती है।

नौकरीपेशा लोगों के लिए आयकर स्लैब में वृद्धि एक खुशखबरी है। आयकर स्लैब को तार्किक बनाने की मांग विगत चार-पांच साल

से ज्यादा हो रही थी, लेकिन आयकर वसूलने में सहजता की वजह से सरकार किसी नई रियायत के लिए तैयार नहीं थी। साल 2014 के बाद अब जो परिवर्तन हुआ है, उसके अनुसार, नई आयंकर स्कीम को स्वीकार करने वाले लोगों को सात लाख वार्षिक आय पर अब आयकर भुगतान की जरूरत नहीं पड़ेगी। दूसरा परिवर्तन यह है कि यदि आप पुरानी आयकर स्कीम को नहीं चुनेंगे, तो आप पर स्वतः नई आयकर स्कीम लागू हो जाएगी। हालांकि, जिन लोगों की वार्षिक आय 15.5 लाख से ज्यादा है, उन्हें

30 प्रतिशत आयकर चुकाना पड़ेगा। संकेत स्पष्ट है कि पुरानी आयकर स्कीम की विदाई होने वाली है। इसका एक अर्थ यह भी है कि आयकर बचाने के लिए होने वाले निवेश में कमी आएगी। वैसे भी आयकर चुकाने वाले लोग ज्यादा नहीं हैं और जो सक्षम वर्ग है, वह आयकर बचाने में सबसे आगे रहता है। आयकर फॉर्म को सरल बनाने के साथ ही आयकर से जुड़े भ्रष्टाचार को खत्म करने के लिए भी ज्यादा सक्रिय होने की जरूरत है।

प्रधानमंत्री आवास योजना के बजट का 66 प्रतिशत बढ़ना उन गरीबों के लिए सुखद है, जिन्हें अभी तक घर नसीब नहीं हुआ है। एकलव्य विद्यालय के तहत आदिवासियों के विकास की पहल प्रशंसनीय है, तो महिलाओं के लिए विशेष बचत स्कीम व बचत बढ़ाने की अन्य कोशिशें भी सराहनीय हैं। बुनियादी ढांचे के विकास के लिए 10 लाख करोड़ रुपये का बजट, राज्यों को पचास साल के लिए ब्याज मुक्त ऋण देने का प्रस्ताव भी समयानुकल है। किसानों को राहत देने की कोशिश हुई है, तो सहकारिता में फिर प्राण फूंकने का इरादा भी जाहिर है। गांव और शहर के बीच यह बजट संतुलन साधने की कोशिश करता दिख रहा है। अर्थव्यवस्था में सुधार के लिए अभी भी बहुत गुंजाइश है, क्योंकि ज्यादातर पैसा उधार से ही आ रहा है। सर्वाधिक पैसा रक्षा पर खर्च हो रहा है। सरकार ने शिक्षा और स्वास्थ्य का बजट बढ़ाया है, लेकिन अभी और की उम्मीद है।

की घोषणा की। सरकार ने चीनी सहकारी समितियों को आकलन वर्ष 2016-17 से पहले की अवधि के लिए गन्ना किसानों को किए गए भुगतान को व्यय के रूप में दावा करने का मौका भी दे दिया है। इससे उन्हें लगभग 10,000 करोड़ रुपए की राहत मिलने की उम्मीद है।

सीतारमण ने कहा, 'उन्होंने कहा कि सरकार अगले पांच वर्षों में व्यवस्था से बाहर रही पंचायतों और गांवों में बड़ी संख्या में

उसके बाद बनने वाली एक नई सहकारी समिति, जो मार्च 2024 तक विनिर्माण या उत्पादन शुरू करती है और किसी भी निर्दिष्ट प्रोत्साहन या कटौती का लाभ नहीं उठाती है, उन्हें 15 प्रतिशत की रियायती दर पर कर भुगतान का विकल्प अपनाने की अनुमति होगी। सरकार ने सहकारी समितियों के

लिए टीडीएस के बिना नकदी निकालने की सीमा भी बढ़ा दी है। वित्त मंत्री ने कहा, 'इस तरह की निकासी पर टीडीएस के बिना सहकारी समितियों को एक वर्ष में 3 करोड़ रु पए तक की नकदी निकालने में सक्षम बनाने का प्रस्ताव है।'

बजट से पुरा होगा हर वर्ग का सपना : मो

नई दिल्ली (एसएनबी)। प्रधानमंत्री नरेंद्र मोदी ने बुधवार को आम बजट 2023-24 को 'ऐतिहासिक' करार देते हुए कहा कि यह विकसित भारत के 'विराट संकल्प' को पूरा करने के लिए एक मजबूत नींव का निर्माण करेगा। साथ ही बजट से हर वर्ग का सपना पुरा होगा।
