





PROFILE & LOCATION OF DADRA NAGAR HAVELI AND DAMAN & DIU



- **UT of DNH & DD** comprises of 3 districts namely Daman, Dadra & Nagar Haveli and Diu with Daman as head quarter.
- **Dadra & Nagar Haveli** is bounded by Valsad district of Gujarat in the north- west and east, and Thane district of Maharashtra in the south and south east.
- **Daman** is a coastal city near southern portion of Gujarat State. It is situated nearly 200 kms north from Mumbai and 95 kms south from Surat.
- **Diu** is an island situated slightly off the coast of Kathiawadi near the Port of Veraval in Gujarat with a coastal length of 21 kms (768 kms from Daman).
- **DNH and Daman** are industrial towns with 6500 industries and approx. 2 lakh laborers

MAIN REGULATORY FUNCTIONS OF DEPARTMENT OF CO-OPERATION

- To organize and register various types of cooperative societies on the basis of principles of cooperation, formulating and registration of byelaws and rules for the effective functioning of these societies.
- To ensure that the general body meetings and if required, special general body meetings are conducted, approve the resolutions made in these meetings within the framework of cooperative Acts and Rules.
- To supervise all types of cooperative societies and to ensure that these societies functions as per the provisions of Act and Rules.
- Revival, liquidation and cancellation of registration of defunct societies.
- To implement the proposed Dadra & Nagar Haveli and Daman & Diu Co-operative Societies Regulation 2021 & to streamline all aspects related to cooperatives in the UT.

CASE STUDIES (I)

THE DAMAN & DIU STATE CO-OPERATIVE BANK LTD.:

- The Daman and Diu State Co-operative Bank Ltd.(DDSCB) came into existence as a separate entity from the Goa State Co-operative Bank Ltd.(GSCB) on 01.04.2017.
- The Bank is having 09 Branches out of which 05 Branches are in Daman and 04 Branches are in Diu.
- The Bank is under administration w.e.f. 03.06.2020.
- The UT Administration of Dadra & Nagar Haveli and Daman and Diu have contributed Share Capital of Rs 7500 lakhs.
- various steps have been taken to improve the CRAR like curtailing expenditure, efficient management of funds, record keeping and management, more stress on the recovery and reduction of NPA's.
- There are 9058 members (share holder) of the bank as on 31.03.2022.

- Established in the year 1963 as a 'Ration Shop' with aim to provide good products at reasonable rate
- Now its amongst the biggest FMCG distributors in Daman District and is distributors for AMUL brand Dairy & Ice-cream products and also agent for AMUL brand fresh milk for Daman District (M/s. Valsad District Co-operative Products Union Ltd.)
- Also distributor for 'AMIDHARA' brand vegetable products (M/s. Valsad-Navsari Jilla Vegetables Sahakari Sangh Ltd.) and the distributors of PATANJALI brand Cosmetic and Natural products
- Serving over 2,25,000 persons of Daman District including 7,162 Shareholders
- Turnover in year 2021-22 was Rs 34.67 Crores
- The Society operates 8 (eight) milk booths at various places of Daman to provide milk at reasonable rates to the public at large.
- Daily milk sales have reached 18,000 litres (Price 910,000/-).

PATHWAY TO FUTURE

PRIORITIES OF THE ADMINISTRATION

i) To make the Daman & Diu Fisheries Cooperative Federation functional.

- a) To provide better services to fishermen and fisheries co-operative societies, a federation has been established & registered in Diu on 06.03.2021
- b) This will benefit 800 members from fishermen community in Diu.
- c) As fish is a perishable item, it requires utmost care, from fishing to marketing. In future we want to establish “Amul” type of cooperative structure. It requires forward and backward linkages. For collection of raw fish, a collection centre of primary society or federation to be established at cluster level with refrigerated facility.
- d) Plan to develop modern preservation methods such as – chilling, freezing, cold storage etc., Development of fisheries infrastructure such as ice plants, freezers, landing centres with good amenities, cold/chill rooms, etc, on priority.
- e) Exploring viable markets for the same.

PRIORITIES OF THE ADMINISTRATION

ii) Establishment of multipurpose federation- Dadra and Nagar Haveli

Plan to set-up milk bottling plant for Production, Processing, Marketing and Selling of Milk & related Dairy Products and to sale products of Mushroom, Brown Rice, Honey etc.

iii) Establishment of women multi purpose cooperative societies

iv) To ensure proper functioning of Natural and Organic Farming Co-operative Society Ltd.

v) To make Tourism Co-operative Society Ltd.

vi) To establish Bal Gopal Savings Cooperative Society Ltd.

vii) To Impart training to various stakeholders of co-operatives

viii) To implement the Dadra & Nagar Haveli and Daman & Diu Cooperative Societies Regulation 2021 in letter and spirit.
