# Cooperation Minister says 24,470 PACS functioning as CSCs

NEW DELHI: Total 24,470 Primary Agricultural Credit Societies (PACS) are functioning as Common Service Centres (CSC) in the country, Cooperation Minister Amit Shah said in Parliament on Wednesday.

That apart, 28,648 PACS are operating as Pradhan Mantri Kisan Samriddhi Kendras (PMKSKs) in 18 states and Union Territories for ensuring easy accessibility of fertilizers, pesticides and related services to farmers in country, he said.

"The government aims to operationalise PMKSKs in a phased manner, in all the PACS," Shah said in a written reply to Rajya Sabha.

ACS functioning as PMK-SKs will serve as "One Stop Shop" for farmers, thus

improving their access to various agriculture-related inputs and services such as fertilizers, seeds, farm implements, pesticides, soil and seed testing services.

This initiative will benefit PACS by enabling them to diversify their offerings and hence, providing stable and additional source of income and generating employment opportunities at panchayat/village level, he added.

Through this initiative, common citizens, especially

in rural areas, will be able to access more than 300 e-services, including banking, insurance, Aadhar enrolment/updation, health services, agricultural services, etc, he said.

In addition, this initiative will provide additional sources of income to PACS, ultimately benefitting crores of small and marginal farmers associated with them, he added.

In order to enable PACS function as CSC, a Memorandum of Understanding has been signed between Ministry of Cooperation, Ministry of Electronics and Information Technology, NABARD and CSC e-Governance Services India Ltd, which will enable PACS to deliver more than 300 e-services to rural citizens of the country. At present, there are around 63,000 functional PACS in the country.

**NEW DELHI:** The government will approach the Supreme Court again to get more funds from the Sahara Group, as three crore investors have sought a refund of Rs 80,000 crore stuck with the company's cooperative societies.

The cooperation ministry has launched a portal for investors where they can make an application to get their money stuck with societies, Minister of State for Cooperation in Rajya Sabha B L Verma said while replying to a supplementary question.

Verma said three crore investors have registered on the portal seeking their money to the tune of Rs 80,000 crore back.

"We have started process to refund money back to inves-

tors in 45 days. We have got Rs 5,000 crore... we will go to the apex court again for getting more fund (from Sahara Group) to pay back all investors. Every paisa of investors of Sahara Group will be paid back," Verma told the House, adding that many investors have got their money back.

He assured that all investors going through the process (on the portal) will get their money back.

"We are refunding money to small investors first with amount of Rs 10,000 each," he said.

The home loan limit has been increased by two and a half times to Rs 75 lakh from Rs 32 lakh for rural cooperative banks, he added.

सहारा समूह से अधिक धनराशि पाने के लिए वह फिर से उच्चतम न्यायालय जाएगी।

सहकारिता राज्य मंत्री बीएल वर्मा ने राज्यसभा में प्रश्नकाल के दौरान पूरक प्रश्नों के उत्तर में यह जानकारी दी। उन्होंने कहा कि सहकारिता मंत्रालय ने निवेशकों के लिए एक पोर्टल शुरू किया है, जहां वे अपने फंसे पैसे पाने के लिए आवेदन कर सकते हैं। अब तक तीन करोड़ निवेशकों ने 80,000 करोड़ रुपए वापस पाने के लिए पोर्टल पर पंजीकरण कराया है। उन्होंने कहा कि हमने 45 दिनों में निवेशकों को पैसा लौटाने की प्रक्रिया शुरू की है। हमें 5,000 करोड़ रुपए मिल गए हैं... हम सभी निवेशकों का पैसा लौटाने के लिए और अधिक धनराशि प्राप्त करने के लिए (सहारा समूह से) फिर उच्चतम न्यायालय जाएंगे। सहारा समूह के निवेशकों का एक-एक पैसा लौटाया जाएगा। कई निवेशकों को उनका पैसा वापस मिल गया है। उन्होंने आश्वासन दिया कि (पोर्टल पर) प्रक्रिया से गुजरने वाले सभी निवेशकों को उनका पैसा वापस मिलेगा।
