## **CIRCULAR**

Subject:- Amendment of Recruitment Rules-2023-Proposal for merger of Dy Commissioner / Assistant Commissioner/Assistant Director and Senior Technical Assistant with the Post of Joint Registrar/Deputy Registrar/ Assistant Registrar/Senior Cooperative Officer and Jr Cooperative Officer of Central Registrar of Cooperative Societies, Ministry of Cooperation – reg.

The Recruitment Rules- 2023 notified vide G.S.R 560(E) dt 01st Sept 2023 for the posts of Additional Registrar, Joint Registrar, Deputy Registrar, Assistant Registrar, Senior Cooperative Officers and Junior Cooperative Officer (Group 'A', Gazetted and Group 'B' Non-Gazetted, Non-Ministerial) created in the office of Central Registrar of Cooperative Societies, Ministry of Cooperation.

- 2. The posts of Deputy Commissioner, Assistant Commissioner, Assistant Director (Group 'A'- Gazetted, Non-Ministerial) and Senior technical Assistant (Group 'B', Non-Gazetted, Non-Ministerial) with incumbents transferred from Ministry of Agriculture & Farmer Welfare to Ministry of Cooperation and these posts are notified by DA&FW vide G.S.R-16 dated 14<sup>th</sup> Feb 2022.
- 3. Above posts are being governed by different Recruitment Rules. Now, it is proposed to merge the above posts with identical pay level with one Recruitment Rules in the Central Registrar of Cooperative Societies, Ministry of Cooperation for effective administrative control:
  - i. 02 (Two) posts of Deputy Commissioner (Group 'A', Gazetted- Non-Ministerial Level-12) in the office of CRCS to be merged with 06 posts of Joint Registrar (Group 'A; Gazetted- Non-Ministerial Level-12).
  - ii. 02 (Two) posts of Assistant Commissioner (Group 'A', Gazetted- Non-Ministerial, Level-11) in the office of CRCS to be merged with 06 posts of Deputy Registrar (Group 'A'. Gazetted- Non-Ministerial, Level-11).
- iii. 01 (One) post of Assistant Director (Group 'A', Gazetted, Non- Ministerial Level-10) in the office of CRCS to be merged with 06 posts of Assistant Registrar (Group 'A' Gazetted- Non-Ministerial Level-10).
- iv. 02 (Two) posts of Senior Technical Assistant (Group 'B', Non-Gazetted-Non-Ministerial, Level-6) in the office of CRCS to be merged with 06 posts of Junior Cooperative Officer (Group 'B', Non-Gazetted-Non-Ministerial Level-6).

- 2. The Feeder posts for Assistant Registrar of Group 'A' Gazetted-Non Ministerial (level-10) is Senior Cooperative Officer, Group 'B' Non-Gazetted-Non Ministerial (Level-7) and Junior Cooperative Officer (Level-6) is feeder post for Senior Cooperative Officer (Level-7). Since incumbents are not available in feeder posts of Additional Registrar, Joint Registrar, Deputy Registrar, Assistant Registrar, Sr. Cooperative Officers and Junior Cooperative Officer, therefore, there will be no seniority issues as a result of merger of these posts.
- 3. Posts of Joint Registrar-01, Deputy Registrar-06 and Assistant Registrar-07 have also been created for office of Cooperative Election Authority and Cooperative Ombudsman. Therefore, these posts are proposed to be incorporated in Recruitment (Amendment) Rules-2024.
- 4. Accordingly, it is proposed to amend the Recruitment Rules for these posts in the office of CRCS, Ministry of Cooperation.
- 5. The suggestion/comments, if any, on the proposed amendment of Recruitment Rules/merger of posts may be submitted to the undersigned within 30 days from the date of issue of this circular.
