IFFCO posts Rs 3,811 cr as profit in FY25

IFFCO posts ₹3,811 cr as profit in FY25

NEW DELHI: The Indian Farmers' Fertiliser Cooperative (IFFCO) on Thursday announced its robust Rs 3,811 crore profit before tax for FY25, marking its third consecutive year of surpassing the Rs 3,000 crore milestone.

Managing Director Dr. US Awasthi emphasised that, "IFFCO's model is now drawing attention globally and countries like Brazil, Kenya, and the USA have expressed keen interest in adopting our nano-based solutions."

IFFCO initiated the Model Nano Village/Clusters Project, impacting over five lakh acres across 203 villages. This initiative led to a 28.73 per cent fall in chemical fertiliser use and a 5.8 per cent rise in crop yields. The

cooperative is eyeing carbon credits by leveraging data from these eco-friendly practices.

Spearheading its growth trajectory is a 47% surge in Nano Fertiliser sales—a leap that underscores India's transition towards sustainable and technology-driven agriculture.

A total of 365.09 lakh bottles of Nano Fertilisers were sold in the fiscal year, with Nano DAP recording a staggering 118 per cent year-on-year growth. IFF-CO's total turnover reached Rs 41,244 crore. Chairman Dileep Sanghani credited this performance to the cooperative spirit and government collaboration, stating that the growth fulfils the national vision of "Sahakar Se Samriddhi."

IFFCO's Nano Urea Plus and Nano DAP sales are equivalent to replacing nearly 17 lakh metric tonnes of conventional fertilisers—12 lakh MT of urea and 4.85 lakh MT of DAP—highlighting economic and environmental benefits.

Further innovation is on the horizon: the launch of granular Nano NPK, Nano Zinc, and Nano Copper in 100ml liquid form is set to revolutionise soil nutrition by boosting productivity and curbing nutrient loss.

Further amplifying its reach, IFFCO distributed over 2.5 lakh sprayers and introduced 1,764 agri-drones to ensure widespread Nano Urea and DAP adoption. Rural entrepreneurs were trained to deliver drone spraying services.

In another key move, IFFCO will establish a Seed Innovation Centre at Kalol to preserve and promote indigenous seed varieties.

Fertilizer co-operative Iffco reports 16% jump in net profit in 2024-25

Fertilizer co-operative Iffco reports 16% jump in net profit in 2024-25

Fertilizer co-operative Iffco has announced a 16 per cent rise in its net profit at ₹2,823 crore in the 2024-25 fiscal against ₹2,443 crore in 2023-24, mainly due to higher revenue. But the turnover had a modest rise of 4.5 per cent at ₹41,244 crore from ₹39,474 crore.

"Iffco has registered a profit (before tax) of ₹3,811 crore last fiscal and it is for three consecutive financial years. The profit is over ₹3,000 crore," Chairman Dileep Sanghani said after the annual general meeting.

He announced a 20 per cent dividend in the paid-up share capital for its over 35,600 member co-operative societies as decided by the Board.

Iffco's Managing Director US Awasthi highlighted that

the 47 per cent higher sales of liquid nano fertilizers (both urea and DAP) was a major milestone during the 2024-25 fiscal, helping the multi-State co-operative to achieve higher turnover.

Awasthi also said Iffco will soon launch Nano Zinc and Nano Copper in liquid form in 100 ml bottles and also Nano NPK fertilizer, which will be in granular form, for soil application in basal dose to fulfil the micro-nutrient need of the soil.

Further, Iffco will build a modern seed innovation centre at its Kalol unit, he said.

Iffco's share in the country's total production of fertilizers (urea, DAP and complex) was almost constant at 17.98 per cent in FY25 against 17.67 per cent in FY24.

Fertilizer production by

Iffco in its all 10 plants rose to 93.1 lakh tonnes (lt) in 2024-25 from 88.95 lt in the preceding year, while sales increased marginally to 113.78 lt from 111.73 lt year-on-year.

SALES UP

India's total production of fertilizers was up 2.9 per cent at 517.83 lt in FY25 against 503.31 lt in the previous year.

Sales of nano fertilizers were at 364.41 lakh bottles (of 500 ml each) in 2024-25, compared with 249.45 lakh bottles the previous year.

Nano DAP had the best growth results with 118 per cent increase in sales y-o-y. But conventional Di Ammonium Phosphate (DAP) sales remained flat at 67.32 lt and 25.62 lt respectively.

Sales of Sagarika brand, under which water soluble fertilizers, specialty and biofertilizers are produced by Iffco, have also increased.

IFFCO's Nano Fertilizers in line with organic and natural farming

इफको की नैनो उर्वरक जैविक और प्राकृतिक खेती के अनुरूप नर्ड दिल्ली (एसएनबी)। सबसे बडी सहकारी संस्था इफको ने कहा है कि नैनो उर्वरक सरकार के जैविक खेती और प्राकृतिक खेती को बढ़ावा देने के संकल्प के अनुरूप ही हैं। कहा जा रहा है कि उसकी राष्ट्रव्यापी मॉडल नैनो विलेज/क्लस्टर परियोजना से रसायनिक उर्वरक के प्रयोग में कमी देखी जा रही है। दो हजार एकड में फैले 203 गांव के क्लस्टरों का चयन किया गया है, जो फसल उत्पादकता और गुणवत्ता में वृद्धि के साथ उर्वरकों के उपयोग को कम करने में सहायक सिद्ध हुए हैं। इस अभियान से 90 हजार किसान जुड़े हैं।

इफको के अध्यक्ष दिलीप संघानी और प्रबंध निदेशक डा. यएस अवस्थी ने एक प्रेस कांफ्रेंस में बताया कि वर्ष 2024-25 में इफको ने कर पूर्व 3811 करोड़ रुपए का मुनाफा दर्ज किया है और नैनो उर्वरकों की बिक्री में 47% की वृद्धि हुई है। इफको ने चाल साल में 41,244 करोड़ रुपए का कारोबार किया है। उन्होंने बताया कि इफको जल्द ही नैनो जिंक. नैनो कॉपर को तरल रूप में 100 मिलीलीटर की बोतल में और नैनो एनपीके उर्वरक को लॉन्च करेगी, जो कि दानेदार रूप में होगा।
